GUIDELINES & FUNDING REQUIREMENTS

Processing Fee	\$295
Tax ID	Will accept applicants with a Tax ID#.
Max Age of Vehicle	Vehicle must be model year 2005 or newer.
Gap	Up to \$1,200 or state max.
Warranty	Must include powertrain coverage (including seals and gaskets). Warranty can be sold for a max of \$7,000. Cannot exceed \$75K amount financed.
Roadside Assistance	Max \$699
Insurance Deductibles	\$1,000 Comprehensive/Collision.
Recourse	Case by case with sign off by both companies.
Restricted Vehicles	Rebuilt, branded/salvage, lemon law, gray market/unknown mileage, total loss, flood damaged vehicles, airbag deployment – including taxis, limousines, police cars, delivery vehicles, tow, ride sharing vehicles, and all discontinued lines – are ineligible.
Commercial Vehicles	Vehicles for commercial use will not be accepted.
Bankruptcy	Will accept applicants in an open Chapter 7 or 13 Bankruptcy. No multiple BKs and cannot be up for dismissal.

Blackout Period: First payment due date may NOT fall after the 25th of the month.
